As we welcome in the New Year, I have some exciting news to announce. We have expanded our Field of Membership and changed our name to Walled Lake Schools Federal Credit Union.

Because a major building renovation over the last six months wasn't enough, we decided to bite the bullet and tackle some of the other key initiatives from the Board of Directors strategic planning agenda.

Effective October 23, 2019 the National Credit Union Association (NCUA) approved our request to amend our charter to add "Students (kindergarten through twelfth grade) attending Walled Lake Consolidated School District in Walled Lake, Michigan" to our Field of Membership. Effective November 22, 2019 the NCUA approved our request to

change our name to Walled Lake Schools Federal Credit Union.

The WLSFCU board consists primarily of retired educators from the school district and expanding our membership to include the students they have taught over the years has been a vision of theirs for quite some time.



To support this membership expansion, we have opened

student-run credit union branches in the WLCSD middle schools, Geisler, Banks, Creek and Smart. Each student-run credit union is open one day every other week and operated by student tellers. A WLSFCU employee is always present to supervise operations and ensure accuracy and confidentiality are maintained. These student-run branches are available for students, parents and faculty to make deposits only to their WLSFCU accounts.

# IRA contribution deadline is April 15

The deadline to make 2019 contributions to your individual retirement account (IRA) is April 15, 2020. The maximum contribution amount if you're under 50 is \$6,000. If you're over 50, the maximum contribution amount is \$7,000.

For information about rolling your IRA over to WLSFCU or to update your IRA beneficiary designation, please contact the Credit Union today.

## Getting a tax refund?

You'll need to provide WLSFCU's routing and transit number, **272485657**, and your WLSFCU account number (please call us to get your account number in the proper format you'll need) on Form 1040 in the section labeled "Refund" if you plan to have your income tax refund "direct deposited" into your WLSFCU account.

# Important tax information about your WLSFCU IRA

The balance of your individual retirement account (IRA) as of December 31, 2019 as reported on your statement is the "Fair Market Value" of your IRA.
